Euro Accident's private medical insurance PrivatAccess gives employees quick access to medical and psychological assessment with a recommendation for appropriate care or treatment, contact with a doctor and if needed planned care and surgery via private healthcare providers. ## **Preferred employment benefit**

Access to the right care at the right time tends to be at the top of the wish list of employment benefits when choosing an employer. You can pay for the insurance for all your employees or offer it as an optional benefit.

## Medical assessment daily 24 hours a day

Employees receive a medical assessment and a recommendation for appropriate care or treatment daily 24

hours a day. If required, a doctor is available digitally via chat or video call. The doctor can also prescribe medication, send for tests and samples or refer to a specialist doctor. In the case of psychological symptoms, the employee can book a telephone appointment for an assessment call with one of our psychologists directly via the app.

#### Visit a specialist in the Euro Accident Authorised Network

If the assessment means that the employee needs to see a specialist doctor, Euro Accident can usually offer an appointment for an initial consultation within 7 working days and surgery within 14 working days. We always recommend a specialist from authorised network which covers the whole country.

#### Good to know

- Insurance is valid for planned private treatment in Sweden.
  For acute treatment abroad PrivatAccess covers travel or home insurance excess up to max 5000 SEK.
- The insurance is available for employees between 16 and 64 years and is valid up to and including the month of your 67th birthday.
- The liability period is unlimited as long as a valid policy exists, which means compensation can be paid for claims up until 67 years of age.
- The insurance even reimburses costs of patient fees in public health care up to the limit for high cost protection.

### **Pre-purchase and conditions**

General pre-purchase information and comprehensive conditions can be found at euroaccident.se. An insurance policy may have conditions that differ from the general ones and will be provided by your insurance broker.

#### Income tax
